2017 Missoula Baby Fair Exhibitor Agreement

1. Once the Missoula Downtown Association has leased the exhibit space to Missoula Baby Fair, they shall make available to the applicant, for the period of the Baby Fair, the space applied for.
2. No signs or advertising devices shall be displayed outside booth area other than those furnished by sponsors and allowed by Baby Fair representatives. Displays blocking the unobstructed view from space to space are prohibited.
3. All exhibits must be confined to the space provided. Exhibitors assume all liabilities and/or obligations caused by faulty or improper displays.
4. Exhibitors shall abide by and observe all laws, rules, and regulations of the State of Montana and the City and County of Missoula, and departments thereof and all rules of the Missoula Downtown Association.
5. Once a contract is accepted, exhibitors shall not be entitled to a refund of any part of any fee should the exhibitor for any reason be unable to attend the Missoula Baby Fair, or cancel any space previously contracted for. **Payment in full is required before space is reserved.**
6. Missoula Baby Fair reserves the right to alter or change the space assigned to an Exhibitor, to alter or remove exhibits or any part thereof, including printed materials, product, signs, lights or sound, and to expel exhibitors or their personnel if their conduct or presentation is objectionable to other Exhibitors.
7. If the Missoula Baby Fair should be cancelled for circumstances beyond its control, i.e., Act of God, Act of War, government emergency, labor dispute, or the unavailability of the site for any reason, Missoula Baby Fair authorities may, but is not required to, refund each exhibitor their paid booth space rental fee, less a percentage equal to the costs incurred by the Missoula Baby Fair to date.
8. Exhibitors **MUST** be in attendance at their space for the entirety of the Missoula Baby Fair open hours to the public.
9. The applicant hereby agrees to indemnify, defend and protect Nursing Nook LLC against, and hold and save Nursing Nook LLC harmless from any and all claims, demands, suits, liability, damages, loss, costs, attorney fees and expense of whatever kind or nature which might result from or arise out of any action or failure to act of the applicant or any of its officers, agents, employees, or other representatives, including but not limited to claims or damage or loss to property, or from or out of any damage, loss, harm or injury to the person or any property of the applicant or any of its officers, agents, employees or other representatives, resulting from theft, fire, water, accident or any other cause. Neither Nursing Nook LLC nor Missoula Baby Fair will obtain insurance against any such damage, loss, harm or injury.
10. Any photos, video, or audio taken at the Missoula Baby Fair may be used for any form of present and/or future advertising and/or promotion.
